

## **Privacy Policy**

We are committed to protecting the privacy of yours and provide you a better gaming experience. We have adopted a Privacy Policy that explains how we collect, use, and use the information you provide us. We refer to Sweet Slots World:Candy Fiesta, together with our services(collectively, the “Services”) in this Privacy Policy.

This Privacy Policy also explains your choices about how we use your information. Your choices include how to object to certain uses of your information and how to access and update certain information about you. By using our Services, you accept this Privacy Policy. If you do not agree to this Privacy Policy, please do not use our Services.

### **01. Information we collect**

We collect various information regarding you or your device. This includes the following:

- Device Information: IDFA, IDFV, GAID, device model, device brand, device language, device network type, screen resolution;
- Internet Information: Mac-Address;
- Usage log.

### **02. How we collect information**

We may collect information in a variety of ways, including:

From you directly.

Through this App: When you use the App or our services, we may collect your information.

From other sources: We may receive information from other sources, such as social media platforms; or other third parties.

### **03. Purposes for obtaining your information**

We will only use your personal information when allowed by law. Generally, we will use your personal information: (a) where we need to perform the contract we are about to enter into or have entered into with you; (b) where it is necessary for our legitimate interests and your interests and fundamental rights do not override those interests; and (c) where we need to comply with a legal or regulatory obligation.

### **04. Your rights and choices**

You have rights and choices regarding your use of the App and the ways we process personal info listed below:

- Access: The right to obtain confirmation as to whether your personal info is being processed, to know what personal info we have about you.
- Correction: The right to have rectified any inaccurate personal info concerning you.

- Deletion: The right to delete personal info that we have collected from you.
- Objection: In some cases required by law, the right to ask us to stop processing your personal info.
- Right to withdraw consent: Where your consent is required, you may at any time withdraw such consent (though this will not affect the lawfulness of any processing of your personal info prior to that).

## **05. How we share your personal information**

We may share the personal information and non-personal information we collect with third parties, such as advertisers, promotional and marketing partners, and others who provide our content or products or services we think may be of interest to you.

We may engage trusted third-party service providers to perform functions and provide services for us, such as hosting and maintaining our servers and services, database storage and management, and customer service. We may share your personal information, and possibly some non-personal information, with these third parties to enable them to provide these services to us and you. We may also disclose your personal and non-personal information to government or law enforcement officials or private parties when we, in our sole discretion, believe it is necessary or appropriate to disclose such personal information to respond to claims, legal process (including subpoenas), to protect our rights and interests or those of third parties, the safety of the public or any person, to prevent or stop any legal, unethical or illegal actionable activity, or otherwise to comply with applicable court orders, laws, rules and regulations.

## **06. Children**

We do not knowingly collect personal data from minors under 13 years old. If a guardian has aware that his or her child has provided us with personal data without guardian's consent, he or she should reach us immediately and we will take reasonable steps to ensure that such data is removed from our files. If you are under the legal age of majority and you need to use our service and submit your personal information, please let your legal guardian submit it on your behalf. You should not provide us with your personal data without the consent of your legal guardian.

## **07. How we retain your personal information**

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal information, we consider the amount, nature, and sensitivity of the personal information, the potential risk of harm from unauthorised use or disclosure of your personal information, the purposes for which we process your personal information and

whether we can achieve those purposes through other means, and the applicable legal requirements.

In some circumstances we may anonymise your personal information (so that it can no longer be associated with you) for research or statistical purposes in which case we may use this information indefinitely without further notice to you.

## **08. How we protect your personal information**

We have implemented technology and policies to safeguard your privacy and personal data from unauthorized access and improper use.
